- 2. To have sudden checks to different ragging prone areas.
- 3. To identify the students involved in ragging.
- To submit report to the anti ragging committee. The report may be considered in the anti
 ragging committee and action may/be initiated.
- To be vigilant round the clock and visit the hostels and the College Campus even in old hours and have surprise cheeks and catch red-handed the students involved in ragging.
